    - b. If it's on your property, you can contact the police

    - a. Minimizes number of officers on shift

    - 1. This is the result of non-compliance of social distancing measures

    - 1. Park staff mostly working in golf courses
  - v. Wendy has there been resistance to ambassadors?
    - 1. Mike not that I specifically know of, but there probably has been resistance
    - 2. This program is taking place at many sites beyond Van Cleve

    - i. Right now the city is likely against it
  - b. People are very worried about a large increase in cases when things open up

  - c. Take-out will likely be popular for some time
  - d. Could possibly go away when things reopen due to need for parking

  - a. Cam Bethesda hospital has been identified as an ICU to help prevent others from being overwhelmed
